**Proposed Budget Report**

An introduction to the process: first, they establish the guidelines and define the criteria to be used; then a preliminary budget is created by a budget officer; department managers then provide department-focused input (ie. they can switch small items around, increase something and decrease something else, but can't add anything big or change anything drastically); the Budget Working Committee then prepare budget balancing recommendations; schools are consulted (principals) and provide internal input; public input is sought; finally, the Board of Education Budget Committee considers the recommendations and public input and approves a balanced budget.

*Requirement to balance:* the School Act requires the District not to incur a deficit. The budget must be balanced to zero by cutting costs, increasing revenues or using reserve funding. The amount of funding available sets the spending limit.

## Factors that influence whether budget will balance:

-structural deficit: if there is less funding available than costs to pay; structural means that, on an ongoing basis, funding is never enough; it's not caused by one specific thing -funding formula that doesn't match the cost structure; funding is given on a per pupil basis but costs don't occur on per pupil basis so this formula can be a mismatch at times -enrolment changes, or proportional change over a period of time; the last few years there has been a rise in inclusive education and that changes the structure of funding -inflation

-contractual cost increases: salary, collective agreements, etc

-benefit changes: these change every year and the rate changes as people become older, etc -amount of funding: if it does not cover all the costs, then the budget won't balance

## How we balance the budget:

-first, look at the district vision, consult it for how we address educational needs -evaluate prior year opportunities; ie. something was less costly, or more -consult with stakeholders and prioritize

-consider possible revenue increases; the district is not a for-profit organization so this is hard to do; sometimes they get grants but there are expectations that go along with them -share needed reductions among all budget areas so no one area is impacted too much; they try to stay away from the classroom as much as possible but as it takes up the majority of the budget, it's very difficult to do that

-reserve funds: if everything else fails, you have to use reserve funds to balance the budget; reserves are created by adding surplus or deficit from the prior years

## Overview:

Operating Budget: \$160.853 million

Enrollment growth of 10 (FTE) students; total 15,407 students in the 2019/20 year

This budget is balanced fully and completely, and there is no structural deficit. No reductions will have to be made.

There is a small surplus of \$63,000.

There is a \$45 per pupil increase this year, to a total of \$7,468 per pupil.
