Funding Formula Review - Laura Dixon, Chairperson, School Board Trustees

The reports for the funding formula are in, but they do not contain numbers or sample formula, and so the Trustees are not sure what to make of them. These reports can be found on the government website. Now, they need to get the reports in the hands of the department heads so they can analyze them. March 15, 2020 is when the funding announcement will be made, and will likely be the time when they release the new formula. It seems as if there's nothing in the reports that are too shocking, but we're still unsure without the numbers.

Assessment Practice - Neil Stephenson, Director of Learning Services

Curriculum Questions

We changed report card format three years ago but this will be the first year with no grades for grades 4-7; the proficiency scale will be used instead, which is: not yet meeting, partially meeting, meeting, excelling. Part of the change focuses on student reflection so there's student voice in the reporting which gives more ownership.

There is a pilot project going on at Heath Elementary. Rather than three report cards, there will be two terms, one in December and another in June. The first term uses three way competencies and an extended parent conference, which is a conversation between the teacher, student, and parent. They write a mini report card during that 20-minute discussion, and talk about literacy and numeracy, and then other areas of concern. Feedback has been very positive. The first year, 95% of parents showed up to the meetings. The District has talked to a couple other schools about this format but no others have jumped on it yet.

Some teachers/districts are using digital portfolios; we haven't done anything as a district with that because there's a lot of complexity around it, though some teachers in our district have used it (ie. Freshgrade).

Grades 8-9, mostly still letter grades, though a few are doing pilots using scales instead of letter grades. Grades 10-12, still on the previous reporting order.

Provincial assessments for grades 10-12 have changed significantly. Grade 10 literacy assessment; grade 10 numeracy assessment; grade 12 literacy assessment Grade 10 numeracy assesses students numeracy across various subjects; math and science, data and

social studies; this result goes on their transcript upon graduation, and is assessed using the proficiency scale (emerging, developing, proficient, extending); Students can rewrite it a number of times.

The District would like the information to be protected data and would like the provincial government not to release the results of these assessments to the outside third-parties that use it for purposes other than it should be used for, but there is no guarantee of that.

The Grade 10 literacy assessment will not show up on transcript except as 'requirement met', and is intended to be used as a formative way to prepare for the Grade 12 literacy assessment.



If your child is in a french immersion school, there will be a french immersion Grade 12 assessment.

What's Coming?

My Ed: the Delta District transition to MyEd BC, on online platform for reporting and other functions; we have been "gently encouraged" to transition by the Ministry of Education. There are a number of student information components that will be moving to MyEd. Currently, we have ParentConnect, but those will slowly disappear over time. Starting in January, we're getting basic demographics, etc, of students in MyEd. The student reporting will go in there, as well as final grades. There are two options currently with reporting, and the Ministry is running pilots around the province to gather information on them. The summer of 2020 should be the new reporting order, so we're in a holding pattern right now. There will be no major changes with report cards in the next year as a result. The District is hoping to sustain ParentConnect the way it is, because MyEd parent portal is very limited right now.

Learning targets: these help to make sure teachers are telling kids what they should be learning, and help kids to know what that day's lesson was about. Next is to provide teachers with ways to check for leaning on an ongoing basis. There will be a revision of District assessment procedure, the rules and principles that all teachers follow around assessment, to help teachers understand the big core ideas: the k-7 continuum says what the most important things are for students to know, and lays it out so it's clearer; it lays out reading benchmarks for k-3 students, information about their reading level. It's not something shared with parents because the District doesn't want to associate kids with a certain reading level; it's just for classroom practices and what's working. It also elaborates on essential learning in math, social studies, and overall what the really important things are to work on. The curriculum is big, and can be difficult to navigate, so these targets help teachers know what the most important things are to focus on.
