NATIONAL INDIGENOUS PEOPLE'S DAY PRESENTATION

Diane Jubinville, District Principal of Indigenous Education, presented on the National Day for Truth and Reconciliation, which occurs on September 30th. She provided some background information on the relevance of the day, how past events have shaped our country, and the importance of recognizing this day. She also spoke about what the district is doing on September 29th to recognize the day, and reviewed the various resources teachers have to use in their classrooms. There will be two Zoom sessions hosted by Nathan Wilson, Indigenous Cultural Enhancement Facilitator, on September 29th to enable students to learn more about National Day of Truth and Reconciliation. Chair Windsor thanked Ms. Jubinville for her presentation as well as the important work that is being done to educate Delta students and staff.

WORLD TEACHERS' DAY

Chairperson Windsor advised World Teacher's Day is held annually on October 5th to celebrate all teachers around the globe. It commemorates the anniversary of the adoption of the 1966 ILO/UNESCO recommendation concerning the Status of Teachers, which sets out the rights and responsibilities of teachers, and standards for their initial preparation and further education, recruitment, employment, and teaching and learning conditions. The theme of this year's World Teacher's Day is "The teachers we need for the education we want; the global imperative to reverse the teacher shortage". Putting an end to the decline in the number of teachers and reversing that trend urgently needs to be at the top of the global agenda. Being a teacher provides an incredible opportunity to make a transformative and lasting impact on learners young and old. It's extremely worrying to see that school districts everywhere are facing teacher shortages currently. On behalf of the Board of Education, she thanked all staff within our district – educators, support staff, school and district administrators, CUPE 1091 and DTA members, as well as parents – for their outstanding hard work and unwavering commitment to supporting Delta students.

Doug Sheppard, Superintendent of Schools, added to Chair Windsor's comments and shared some of his thoughts on why this is such an important day for all to recognize. In Delta, achieving our Vision for 2030 of being an innovative, inclusive community where all learners belong, and everyone soars is wholly dependent on being able to build positive connections with our students. When students feel supported and safe, they are far more likely to engage in learning, which ultimately can lead to better academic success. We need sufficient staff, period, to be able to do this important work, and that system will foster these powerful connections and provide the best learning environment for all of our students to flourish. Superintendent Sheppard invited everyone to join him on October 5th,

The Auditors issued an unqualified audit opinion which means that the financial statements present the financial affairs of the district fairly in all material respects, in accordance with s.23.1 of the Budget Transparency and Accountability Act of BC. All the reports will be available to view on the Delta School District website. Joe Muego, Chair of the District Audit Committee, thanked Nicola Christ and her team for their great work and provided the Board with the committee's recommendation for approval of the 2022/23 Audited Financial Statements. The Financial Statements must be forwarded to the Minister of Education by September 29, 2023.

Inspired Learning

The Public Interest Disclosure Act (PIDA) establishes "whistleblower" protection for employees in the public sector. Originally in effect since December 1, 2019, it comes into effect for school districts on December 1, 2023.

Boards of Education are required to undertake the steps listed below to prepare for the implementation of this legislation by no later than November 30, 2023.

Requirements are as follows:

- Implement a Policy, Administrative Procedures and Disclosure Form.
- Provide all employees with training.
- Complete an Annual Report within six months of the end of the reporting period, beginning with the first report for the period of December 1, 2023 to June 30, 2024 which is due by December 31, 2024.

Based on the Board's work in September and October, Nicola Christ, Secretary Treasurer, will present the finalized Public Interest Disclosure Policy, Administrative Procedure, Disclosure Form and Annual Reporting Template for Board approval.
